The Department of Energy at the Prime Minister's Office ("DOEPMO"), Brunei Darussalam wishes to invite eligible consulting firms (local or international) to submit their bids for the provision of consultancy services to support solar development in Brunei Darussalam. This tender covers the three main scope of work, Renewable Energy National Power System Studies, Recommendations on threshold capacity of Small-Scale Solar Penetration and Capacity Building to assist and upskill DOEPMO to deliver solar projects with quality.

Note: Reputable local consultancy firms can participate in this tender, either independently or through joint venture/consortium with qualified international partners.

Scope of Work and Main Deliverables:

Scope	Main Deliverables
Renewable Energy National Power System Studies	Comprehensive report and maps showing potential locations for renewable energy plants with their maximum hosting capacities, investment costs and recommendations for grid-safe deployment.
Recommendations on threshold capacity of Small-Scale Solar Penetration	Comprehensive report and maps showing locations with their allowable solar injection threshold within the Distribution and Low Voltage Network. This also includes the 'rule of thumb' principle of the solar penetration.
Capacity Building	3 days face-to-face trainings for DOEPMO personnel on technical and non-technical topics.

Qualifying Criteria:

This invitation to tender is open to renowned and experienced consulting firms that have

- Proven experience in advising, consulting and/or delivery of both Small-Scale (<1MW) and Large-Scale Solar Projects (>1MW) with an advantage given to those who have experience in local/regional solar projects; and
- Must demonstrate track record in power consultancy, including strategy development, conducting detailed technical grid studies involving integration of solar, energy storage system within conventional power system; and
- Demonstrated track record in solar delivery contract management.

Further requirements:

- Must speak and write fluently in English Language and have excellent written, presentation and reporting skill.

- Must be familiar and have tangible experience to all relevant industry standards, codes and regulations in ASEAN and Brunei Darussalam.
- Must have a stable financial background and demonstrate the ability to meet the financial requirements of the project.

Registration Procedure:

To register for the tender, interested tenderers should send an email to renewable.energy@energy.gov.bn with the subject heading: 'Provision of Consultancy Services To Support Solar Development In Brunei Darussalam'.

To obtain the Tender Documents, a non-refundable administration fee of B\$100.00 (One Hundred Brunei Dollars only) is required in the form of Online Transfer made payable to the 'Government of Brunei Darussalam'. Once payment is received by Finance Unit, Prime Minister's Office at the address stated, the Tender document will then be issued.
